The *Camping Municipal de Brouillet* reserves you, according to its conditions (written below), a pitch on the campsite during the given dates.

GENERAL CONDITIONS OF PITCH RENTAL

The following general conditions for a pitch renting have been understood and agreed and the campers are required to respect them:

All reservations are made in the hire's name and can not be transferred.

The minimum length to make a reservation is one week.

The reservation becomes valid after our agreement and after the receipt of the booking reservation fees.

Any payment not accompanied by a signed and fulfilled contract will not ensure the reservation.

You will receive an e-mail once the *Camping Municipal de Brouillet* has accepted your reservation.

If your arrival is delayed, please let us know: in the absence of a message from your part, the lease becomes vacant 24 hours after the date mentioned in the contract. The telephone messages must be confirmed in writing.

In case of late arrival, you must keep informed the reception team. If you arrive later than the opening hours, a night watchman will be available to welcome you and show you your pitch in the camping.

The day of your arrival, you will show your copy of the contract and your passport.

In case of cancellations, the reservation booking fee will not be refunded except in the following situations: death in the family, serious illness and hospitalisation. Supporting documents will be required.

The customer is informed that *Camping Municipal de Brouillet* does not take any responsibility for theft, fire, bad weather or any incidents concerning the civil liability of the campers.

Every camper is required to adhere and follow the internal rules and procedures of the *Camping Municipal de Brouillet*

In case of litigation, Mende courts are the only ones that have jurisdiction.
